### **President's Message**



We had a great 2012 in our community and I am looking forward to more improvements in 2013. We have two large capital repairs set for this year. We have signed a contract to repair and repave the walking path along Lees Corner Road north of Roger Mack Drive to the end of our property line. This repair will cost \$40,500, but we will offset \$4,700 from a community improvement grant from the County. We also plan to repair and repaint the two basketball courts on Beech Down Drive. We are waiting for a final proposal, but expect the price to be around \$20,000.

We were contacted recently by the Fairfax Storm Water Planning Division about the large storm water pond at the corner of Bellerose Road and Beech Down Drive. The County would like to modify the pond to allow it to better clean the water before it is released into the Chesapeake Bay watershed. This is a significantly smaller change than they proposed a few years ago. We will be holding a special community

meeting on this topic on January 24, 2013 at Franklin Middle School. All of the homes in the immediate vicinity will receive a mailing from the County and we will be posting the information on our website and Facebook page. Everyone is encouraged to attend the meeting and let us know your thoughts on the modifications. We have been living with the pond in its current state for many years. It is the board's opinion that the changes may improve the overall look of the pond as well as improve water quality.

As always, we are looking for volunteers to help out on our committees. Please let me know if you are interested in helping out Armfield Farm on our Social or Architectural committees.


### **Neighborhood Safety**

### **Storm Water Pond**

In November, representatives from Fairfax County's Department of Public Works and Environmental Services met with the HOA Board of Directors to recommend converting the open field area near the intersection corner of Beech Down Drive and Bellerose Road into an Extended Detention Pond. As the runoff from our properties works its way to Cub Run towards the Chesapeake Bay, this topic is important to many sectors of the community. The proposal would allow the basin to draw down at a slower rate after rainfall in order to remove pollutants more effectively and to support a functioning biological community of native plants, which in turn provide a habitat for birds, amphibians and other wildlife.

On January 24th at 7pm at Franklin Middle School, the HOA Board will be hosting County representatives to discuss the proposal in a community wide meeting. Please visit www.armfieldfarm.org for any materials available in advance.

### **Armfield Farm Receives Second NEPP Grant**

Fairfax County, for the second year in a row, has selected Armfield Farm as one of the top proposals for the Neighborhood Enhancement Partnership Program. This year, we will receive \$4,700 towards rehabilitating the Lees Corner Road walking paths between Roger Mack Court and the Montessori School. A portion of the grant does have to be matched with "sweat equity," so look forward to a call for assistance in cleaning up the community and other service projects.



### **Spring Construction - Submit your Applications Early!**

Although it is hard to believe that it will be Spring again in a few short months, many of our neighbors are already planning their next exterior home improvements. If you are one of these, please make sure to take a look at the Architectural Guidelines and submit any applications with enough lead time. The review board meets monthly, so you do not want to have to halt your projects to wait for HOA approvals. Or worse redo the project if it does not meet the guidelines. And please remember, the board is all volunteer, so there is no expediting process.

Some common areas where owners have run into trouble are:

- Rear fencing that gets installed to the front of the corners of the home, instead of being installed on either the rear corner or halfway up the side;
- Fences that do not follow the property line, or the wrong type of material for a fence;
- Sheds that are oversized, improperly placed, not matching the color of the house, or are made of non-conforming materials.

The goal of the Guidelines are to assure all homeowners that the character and appeal of the whole neighborhood will be maintained. This, in turn, protects property values and enhances the community's overall environment. Many times, when an application can not be approved, your neighbors on the Architectural Review Board can provide guidance and alternative that may even better suit the owner's needs.

### Springhaven Drive/Beech Down Drive Stop Sign

Following a community meeting with County traffic and Board of Supervisors representatives on October 11th, 84% of the balloting area (covering Springhaven, Malin, and parts of Beech Down and Armfield Farm) voted to recommend that the Springhaven/Beech Down intersection be made a four-way stop. The County Board of Supervisors will vote on the traffic calming device at an upcoming meeting, the earliest being January 29th. If approved, signs could be installed shortly after that time. We remind homeowners & renters that any <u>architectural and/or exterior changes re-</u> <u>quire an application and approval.</u> To gain approval for changes, submit an application to the Architectural Review Board (ARB) using the *Armfield Farm Homeowners Association Exterior Alternations Application* (related changes can be included on the same form).

The Armfield Farm HOA Board and Capitol Property Management Company are committed to ensuring that residents remain compliant with the guidelines set forth in the association's Architectural Design and Maintenance Standards. If/when compliance is not followed, applicable <u>penalties will be applied to homeowners and renters who violate the</u> <u>guidelines.</u>
