President's Message



Happy Winter everyone! We had a great 2014 and I am looking forward to a number of improvements in our community in 2015. We finally received the permit from Fairfax County to install the two new shade structures at the pool. They will be installed in the spring well before the pool season begins. We also budgeted for a number of capital improve-

ments and repairs including a complete rebuilding of the volleyball court by the pool. The court has very bad drainage and every time it rains it becomes a lake for days. We will be

removing all of the existing sand and installing a layer of gravel with french drains. Sand will be placed above a fabric layer to separate it from the gravel and provide much better drainage. We will also be installing a professional grade net and posts.

We also approved funds to repaint and fix the cracks at the tennis courts, replace the fences at the basketball courts, and replace the hot water heater at the pool house. In addition we have budgeted \$25,000 to continue repaving the walking paths in our neighborhood. We are hopeful that drop in oil costs will lower the cost of the asphalt and allow us to do more sections of the path.

We are always looking for ideas on how to improve the neighborhood. Please send me an email with your suggestions.






Guest Column - Virginia Delegate Tom Rust

The HOA received this letter in early-October 2014. Del. Rust requested it be provided to the Community.

Because I know how important repaving of the roads in Armfield Farm is, in August 2013 I met with VDOT officials to determine the status. They informed me the roads were tentatively scheduled to be repaved in 2015, and I informed residents of the news. I recently met with Virginia Department of Transportation (VDOT) officials to receive a repaving update. At my meeting with VDOT, they explained that the tentative road paving schedule which I was given last summer has unfortunately been pushed back indefinitely and they have had to shift priorities with respect to secondary road paving. They stated they had to make the tough decision due to many unforeseen factors, including:

- An unusually harsh winter which caused VDOT to substantially exceed their budget by approximately \$200 million.
- Statewide forecasted transportation-related revenues are down by approximately \$800 million over the 2014 – 2019 time period, leading to a reduction in funding made available for paving in the Construction Program.
- A similar negative impact on VDOT's construction program has also occurred.
- VDOT must now also update handicap ramps to be ADA compatible when they repave a road. Over 2,000 ramps will be updated this year at a cost of \$3 million, which is money not able to be used for paving.
- The paving contract for 2014-15, which should be complete by June 2015, has been pushed to November 2015 because of budget constraints. This has had a ripple effect on the 2015-2016 budget.

You should also know because it is cost effective to repave all the roads in a subdivi-



sion, repaving Armfield Farm will cost approximately \$880,000.

To give you a barometer of the magnitude of repaving needed in Northern Virginia, I would encourage you to visit <u>www.virginiaroads.org</u>. Under "Pavement Conditions and Paving Scheduled", it appears over 50 percent of the roads in Northern Virginia are in "very poor" condition (which includes most of the Armfield Farm

I regret being the bearer of bad news, but I have told VDOT that the number one priority for repaving in the 86th district is the Armfield Farm subdivision because of the volume of "very poor" roads. In the meantime, if potholes appear please contact me with the exact location and I will ask VDOT to repair them immediately.

Again, I regret the turn of events which has caused a delay in repaving Armfield Farm roads. I only hope this winter is mild, to avoid any further budget impacts.

The Armfield Farm HOA Board and Capitol Property Management are committed to ensuring that residents remain compliant with the guidelines set forth in the Association's Architectural Design and Maintenance Standards. If compliance is not followed, applicable assessed charges can be applied to homeowners who violate the guidelines.

There will be a pedestrian improvement project along Lee's Corner Road that Fairfax County is about to begin. The project will provide sidewalk and related



improvements along Lees Corner Road from Route 50 to Bokel Drive. Construction is scheduled to begin about January 15, 2015, and last
