STOP!!! Don't throw that hazardous waste in your trash. Fairfax County has a hazardous waste program to allow for proper disposal. Residents are encouraged to bring wastes such as pesticides, insecticides, herbicides, old gasoline, used oil, paints and paint thinners and other hazardous materials to the hazardous waste collection The closest site for AHA members is at the Fire and Rescue Academy located at 4600 West Ox Road. Collection will take place the first and third Saturdays of each month from 9:00 a.m. to 3:00 p.m. Any questions about this program should be directed to Fairfax County, Mr. David Duncan at 246-3937 or 246-2852. A reminder that the transfer station at West Ox Road accepts used oil and batteries during all business hours. Consider our ground water and the future when disposing of hazardous material!

For those of you who attended the annual meeting, thanks for your considered interest. A quorum was obtained because R & R (Saville Chase Developer) was able to establish one with their presence. Next year we probably won't have this luxury. To call an official meeting, money is utilized in mailings, announcements, and other preparations. Next year, please either attend the meeting or mail in your proxy. People who didn't bother to mail in an already stamped proxy should reflect on the outcome. Additional meetings will be required to be called until a proxy is present by mail or in person. Save us the money and a lot of hard working volunteers the frustration.

A reminder, the Board continues to work to enforce the no trash receptacle visible rule. Keep your trash receptacles out of sight. With the pool opening, parents need to review pool rules with their children. We have had a good safety record and we wish to keep everyone healthy that is using the pool. The pool parking lot is to be used for people using the pool and tennis courts. No overnight parking is permitted.

We have had complaints about children and teenagers cutting across individual homeowner property. Remind all concerned that proper access is via sidewalk, path or street.

Additionally, those homeowners with dogs are reminded of the Fairfax County leash law.

Residents continue to complain about dogs "doing their business" on their property.

Please be considerate and control your pet.

Lastly, I want to personally thank Bill Dolan for all of his hard work in the neighborhood. Serving on the Board with Bill was an excellent experience. He has been a hard worker and did a super job as Treasurer. His insight will be missed.

BOARD OF DIRECTORS MEETING APRIL 17, 1990 MINUTES - HIGHLIGHTS

Two letters were received concerning trash in the sewer drainage area off Beech Down Dr. An individual was hired to clean the area once. The Board will review options for continued maintenance of this and other areas which seem to have trash problems. Cars/vehicles in violation of Armfield Bylaws are being tagged by the Management Company. According to Armfield attorneys, individuals who purchased a home within Armfield agree to abide by the Covenants and Bylaws of the Association. Any resident in violation of those Bylaws is breaking his/her Contractural Agreement with Armfield. It is the responsibility of the Board of Directors to enforce the

Covenants and Bylaws of the Association.

A walk through of Saville Chase is scheduled to survey and list items R & R still needs to address before the bond is released. Parcel GG in Saville Chase is still a problem in that the Record Plat shows the parcel to be conveyed to Armfield Homeowners Association but the County and R & R seem to think it will be turned over to the County. A certified letter will be sent to R & R, the Fairfax County Park Authority and the County Inspector's Office notifying them that we do not intend to turn over this parcel to the County and we do not wish R & R to attempt to do so either.

Two signs were uprooted on the pool grounds. Signs will be replaced at the entrances to the pool parking lot. No trespassing/No parking between 10 pm and 7 am signs will be placed in order to deter vandals and prosecute those in violation.

Current Armfield insurance policy will cover the swim team, swim meets and craft fairs held at the pool.

The meeting with Armfield's attorney concerning Coscan's responsibility for the problems with the pool addressed the following:
* The pool is losing water.
The cause not yet determined.
Tests need to be done to determine the problem(s). The cost of the tests (\$2,500) will be paid by Armfield but we will attempt to have Coscan reimburse those costs.

- * Back stroke pennants will be repayed by Coscan.
- * Diving insignia will not be covered by Coscan.
- * Caulking at the wading pool will not be covered by Coscan.
- * Coscan will attempt to repair the expansion joint in the pool.
- * Coscan will put in a fenestrated drain to relieve the standing water problem in the grassy area.
- * Armfield will repair the security lights but Coscan will cover the cost.
- * Coscan will caulk hairline cracks in the pool deck.

There was a separate meeting with MBC, the Pool Committee chairman, and Armstrong Management to discuss problems. MBC states that the water loss problem is the only thing for which they are responsible. An independent structural engineer will come out and do some tests over the next few months. We will attempt to have Coscan cover the cost of these tests.

Jim Armstrong reported on the last meeting of the ARC which he attended along with Wes Schroeder. The committee is losing some members and will need three new members appointed. Armstrong will be preparing the ARC applications before their meetings to help the decision making process be more organized and expedient. Procedural outlines will be drawn up for the ARC to follow.

Farah Shahi is a new member of the Land Use Committee.

The committee presented to the County a point paper on our opposition to the widening of Lees Corner Rd.

Draft of common area management resolution and Release/Indemnification Agreement was presented for comment. Given Resolution #111 A-1-1990. A motion passed unanimously to accept the Resolution.

A letter was received from Fairfax County Supervisor Martha Pennino's office indicating their awareness of Armfield's address change.

ARC survey summary done by management company was provided to the Board. Approved and unapproved architectural changes were noted. Items not approved will be reviewed by the ARC.

BOARD OF DIRECTORS MEETING MARCH 20, 1990 MINUTES - HIGHLIGHTS

Minutes of Jan. 23 and Feb 22 meetings were approved. Motion passed unanimously to publish Minute highlights in the newsletter.

Management company has notified the following groups and individuals of the correct address for AHA: Land Records, Real Estate Assessment Office, Planning Commission, Environmental Management Office and the Board of Supervisors.

Postal account will be opened for newsletter and other mailings.

Management company is waiting to discuss ruts at new playground with Rec-creative. Before bill is paid they must repair ruts.

After April 28th tennis court keys must be obtained from the management company.

Outside memberships do not include tennis privileges.

There will be a \$20 registration fee for swim team with a maximum fee per family of \$50.

Coscan, Bill Marr, Steve Kellam, Leye Chrzanowski and Armstrong Management are meeting to discuss pool repairs and who is responsible for fixing these problems.

Motion passed unanimously to accept Green Thumb's bid to maintain the common ground.

Motion passed unanimously to void contract with Willie Collins the maintenance man.

A letter from Martha Pennino to Charles Waddel was passed out. Pennino now favors planning for 6 lanes for Centreville Rd. but at this time paving only to 4 lanes.

VDOT representative has drawn up plans for a 4 lane Centreville Rd. with land being acquired from the west side of the road.

Steve Kellam made a presentation at the Task Force meeting and will also make one

at next week's meeting. He will continue to make presentations at each meeting.

Heather Ambrose has been nominated to run for the Board of Directors.

Armstrong will run and oversee the election. Procedures will be the same as last year.

Analysis of the reserve fund will be made available during the Treasurer's report at the Annual Meeting.

A petition was submitted by 1/4 of the homeowners to request a Special Meeting to discuss the widening of Centreville Rd., the Comprehensive Plan Review Task Force and land use planning and community input. Petitioners have requested that if Special Meeting is in conjunction with the Annual Meeting that they be allowed to speak first. The Board has offered to include this business during the New Business time period. This offer was not accepted by the petitioners. In light of this, a motion was made and passed unanimously that arrangements be made to hold a Special Meeting in May. The Association Secretary will make arrangements to use the cafeteria of Franklin Intermediate School.

Motion passed unanimously to renew a C.D. at the highest possible rate available for 12 months.

GROUNDS COMMITTEE UPDATE

Cable is still being installed in sections 3, 4, 5 and 6. There were some problems boring under driveways on Springhaven due to the dense rock. Media General is repairing the driveways and will also plant grass seed to restore the grounds to their pre-existing condition. In addition, Media General will provide landscaping around some of the amplifiers and larger cable boxes. This will be done near the completion of their project.

We are continuing to work with Green Thumb with the grounds maintenance. Several bad areas of poison ivy have been identified and will be treated soon.

Street light petitions are still being circulated in section 4.

The Department of Environmental Management's County Arborist, Mrs. Randall, addressed a question raised at the annual meeting concerning removal of large trees from private property. According to Mrs. Randall, a homeowner can have up to 5,000 square feet of trees removed without County permits.

Letters were sent out to Mrs. Pennino, Fairfax County Park Authority, Fairfax County Inspector, and Richmarr regarding parcel GG in Saville Chase. The field is deeded to Armfield Homeowners Association and we notified them of our intentions to retain the parcel as Association property.

Letters have also been sent out to Richmarr and several county offices to address bond release issues in Saville Chase. Any Saville Chase residents who have noticed problems in the common area please call me at 471-6258 so that we can have Richmarr correct them.

LAND USE COMMITTEE By Steve Kellam

I received a couple of questions at the Annual Meeting which I want to address. The first question dealt with the resurfacing and realignment of Lees Corner Road. Why did VDOT do it and are they aware of the hazard they have created. The second question dealt with the timer on the light at Route 50 and Lees Corner during early morning hours. A suggestion was made that a traffic sensor should be utilized during off peak hours. I was also asked what they were doing with the bridge on Lees Corner. Phone calls to VDOT resulted in one answer. The bridge was simply being redone due to deterioration with no improvements except new side rails. This will be old news by the time this is published. I have sent a letter to VDOT

on the other two issues. The letter was mailed May 8th.

Based on information received from the Centreville Road Citizens Coalition, I put together a proposed letter for AHA residents. After Board approval, it was distributed the weekend of 12 & 13 May. This handout asked you to sign a letter favoring acquisition of property for six lanes on Centreville Road but favoring building four lanes at this time. The most recent VDOT plan was to build 6 lanes from Herndon to McCleary Rd. and leave it two lanes after that. Talk about a bottle neck!! A meeting was to take place the 21st on this issue. Since the newsletter deadline is prior to that, I will update you with other information via the next Newsletter or a flyer if urgently required.

I continue to attend Centreville Task Force meetings. I hope to present a paper opposing the extension of Springhaven Drive at the next meeting. Don't forget to write letters to the Board of Supervisors and the Planning Commission on the issues. Only you can represent your individual opinion on growth issues. Without your continued input at the County level, you may be looking at increased density in the Ox Hill and Chantilly Estates, along with a 6 lane Centreville Road, 4 lane Lees Corner Road and Springhaven Drive becoming a cut through for traffic between Centreville Road and the Fairfax Parkway. Stay involved!

LETTERS TO THE EDITOR

TO: Armfield Editor FROM: B. Laffitte-Smith RE: Centreville Road

On May 21, 1990 the Board of Supervisors will reach their final decision concerning the widening of Centreville Rd. Prior to that decision, members of the Centreville Coalition have met with most of the Supervisors. On May 6, we met with Chairman Audrey Moore in her office. Here are a few points that were discussed:

- VDOT's only motive to widen Centreville Road to 6 lanes was that it would be cheaper to do it now than in 6 years.
- Transportation Advisory Committee (TAC) recommends a 6 lane acquisition but 4 lane construction.
- Chairman Audrey Moore believes that 6 lanes in the future will be necessary because of the new Bill 170 (Rt. 28 District) but WILL SIDE with Mrs. Pennino's proposal and the Centreville Coalition, if grading and drainage are done when the four lane construction begins. This would minimize the cost of construction for the remaining lanes. The changes from 4 lanes to 6 lanes may take place in 6 to 12 years. After the County reaches its decision, the State will decide the final outcome. date has been fixed yet.

Our purpose is to enable parents to leave their children and feel secure that they are being well cared for and also have the convenience of exchanging time rather than money. By using the Co-op members can enjoy many activities with their children and they can also have some time to go to the Doctor or even do some shopping.

As a member you will get a copy of the Bylaws and 20 coupons to exchange for sitting. All we ask in return when you join is to attend the business meetings every other month, pay \$2 dues per year (money goes towards planned activities and parties) and participate in planned events, (usually every other month and geared for family participation.

This Co-op not only benefits the mother by enabling her to make new friends in her own neighborhood and by finding responsible child care, but it benefits the children by enabling them to find playmates their own age. Fathers are also encouraged to participate and are welcome to join us in any planned activities.

They Take: Plastics - Milk Cartons 2 Litter soda bottles Liquid determent bottles Cardboard - Any kind. (Remove cereal box limers. etc.)

Food Cans - (Remove labels) Glass - Sort by color

Tips for recycling

Set aside some boxes or bags in a corner of your basement, garage or laundry room. Mark them with labels: "Glass" "Aluminum Cans", Plastics" "Cardboard" "Food Cans" and "Newspapers". Sort your trash. Then, once a month, or whenever you find it necessary or convenient, take everything to a recycling center.

Rinse all cans. bottle. and tars. They ask that you do this, but in order to store the containers in any part of your house, you would want to be sure they were rinsed anyway so as to not attract any bucs or rodents!

Glass needs to be sorted by color before dropping in the bins. Remove lids, but no need to remove labels.

Boxes, such as cereal boxes and otner food package fold into a flat. compact size by opening the bottom of the box.

Even the smallest efforts of recycling are worthwhile and helpful to our environment. The bigger the efforts, the more good they can do. For more info, call either of the phone numbers listed above.
