
you brought some spring flowers home.

Survey Directions

On the enclosed yellow page, you will find a survey that the Board of Directors are asking all residents provide feedback on what should be done in the community. Being part of a Homeowners Association is a delicate balance between the wishes of all members, legal requirements, and keeping a strong character of community. The best HOAs are those who have active participation from all of their members. Please consider spending a few minutes to give the Board your opinions.

There are eight questions on this survey. The first asks about trash service. Our community is primarily served by two companies who have pickups on separate days. There is no weekday that does not include cans or bags on the side of the street. Some have asked to have the Board use the power of numbers to negotiate a single bulk price contract in order to reduce truck traffic and wear and tear on our streets. Others wish to maintain their chosen service due to disputes or displeasure with other companies. The Board wants to get a feel for the community's interest in this idea.

The second question will provide guidance on what to do with the land occupied by a merrygo-round / playground that needs to be removed as it is past its lifespan. This playground is located north of the Kew Garden and Brockmeyer Court entrances to the interior walking paths.

The third asks for your help in prioritizing future projects. There are varying costs to each of these projects so dependent on your feedback, multiple small projects or a singular large project may be addressed.

The fourth through seventh questions address our entrance signs and monuments. There are four entrances with three different names reflecting the legacy sub-divisions of our association. It has been a moderate priority, but been delayed in favor of more pressing needs. For this year, replacing these signs is the best fit for an available Fairfax County grant. The Board will be submitting a proposal to subsidize replacing one or more of the entrance monuments for our community to create a stronger identity. However, there are several options available and the Board would like input from all community members. For question six, here are four possible options of shape and style. If you have other suggestions please list the community and where we can find an example of the signage.

Once complete, you can mail the survey to our property management company by folding it in thirds. A 46¢ stamp is required. If you do not want to mail the survey, you may drop it off at the pool. Responses are requested by August 4th. Results will be published in the next newsletter. Thank you in advance.

Timber Run @ EDS - New Development

Last Fall, we advised that there would be construction starting on a new development between Wall Road and EDS Drive along Centreville Road. This past month, heavy equipment has taken down the trees at the end of Wall Road to relocate the ball fields currently occupying the land where the housing/commercial development will be. Expect once that the grading work to make the fields play ready, that work will then take place on the other phases of the project.

Dulles Discovery

As you have likely seen along Centreville Road, the construction on the third large office building has made great progress. The stone façade is now being lifted to cover the support structure of this building and the frame work of a smaller fourth building is being erected.



We reported in the Spring 2012 edition that the next building was slated to open in June 2014. In addition to the office construction, in June 2013, the County approved a pri-

vate overpass to cross Wall Road to connect the two secure compounds being occupied by a large government agency. A timeframe for the construction or impact on those using Wall Road/Air & Space Museum Parkway to Route 28 has not yet been released.

Centreville Road

The HOA is still working to improve the intersection of Armfield Farm Road and Centreville Road. While efforts to put signage on the light pole has not been successful, the County is investigating whether light timing could improve safety and traffic flow.

Additionally, due to a suggestion by an Armfield Farm resident, VDOT will be addressing the Centreville Road entrance to Sully Plaza with painted arrows and signage. The entrance has been a source of concern as it is unclear that the northbound lane does not continue to Metrotech Drive. The schedule for this is pending.

Storm Water Pond Retrofit

As was noted in the last issue, the HOA Board of Directors after hearing community input via a survey of affected residents voted to continue the process to retrofit the storm water pond near Bellerose and Beech Down Drives. The County provided initial engineering drawings that were posted in early-May for resident review and were brought in hard copy to the annual meeting. These copies are now at the pool.



During the June Board meeting, the HOA requested changes af-

fecting the location of some of the pools closest to residents and the maintenance access road to the outflow pipeline to be less impacting and use our existing pathways versus building a parallel route.

Suggestions on this or any other effort are always welcome to president@armfieldfarm.org. The construction schedule is still do be determined based on the County budget.

Yard Waste



Starting in May there has been an increased effort to reduce the instances where grass clipping bags are left on the curb for days before being picked up. Initially, there were between 40-50 homes every week not in compliance with the architectural guidelines in this area. Recent weeks have seen that number drop to between 8-20 homes. Thank you to all residents for their efforts, coor-

dination with lawn service companies, and addressing this concern with your neighbors.
