### Armfield Entrances Get a Facelift Just In Time For Spring

Just in time for spring, the HOA Board has approved a proposal submitted by STM Landscape Services, Inc., to rejuvenate all four entrances to the community.

At the March Board monthly meeting, STM designers presented various options for upgrading the landscaping, incorporating uniform flora and colors at the Armfield Farm Drive, Springhaven Drive, Bokel Drive and Bellerose entrances to promote unity and a cohesive Armfield identity.


The Board elected to put the entire landscaping proposal into immediate effect, as opposed to phasing it in over two to three years. The benefits of one-time installation are two-fold: First, the community will see a dramatic improvement in landscaping this spring; second, STM offered a significant discount for its services to incorporate all landscaping at one time.

Responding to community suggestions, the Board directed STM to make flowering plants in colorful beds a priority. Flowering perennials will be incorporated into beds in which new trees and shrubs will replace the existing juniper, and a beautiful liriope border will add to the effect.

An Amur Maple, resplendent in red and yellow shades in the fall, will be planted at the Armfield Farm Drive entrance, the only entrance large enough for a tree of this size and the most publically visible entrance. This deciduous tree has dark, glossy green foliage in the summer. Fragrant white flowers appear in April and May.

Shrubs selected for all entrances include Rutger's Pyracantha, an evergreen with showy orange-red fruits in the fall, and Little Princess Spiraea with its flat clusters of rose-colored flowers in the summer. In addition, all beds will be planted with these perennials: moonbeam Coreopsis, a drought-tolerant plant which produces an abundance of delicate yellow flowers throughout the summer; Big Blue Liriope with deep green foliage through summer and into winter, and lavender flowers in the fall; Dwarf Pennisetum Grass, a cascading ornamental grass with flower plumes blooming in mid-summer and persisting into the fall; Salvia Blue Hills, a long-blooming perennial with blue spike-like flowers; and Purple Coneflower which has beautiful purple petals.

STM will begin installing the new plants shortly. Look out for glorious floral displays soon!

Cul-de-sac residents need to be prepared to post direction signs to let buyers know they are there. Buyers like to stay on the main roads.

### **Recent Board Activities**

The following notes are taken from the minutes of the Board's meetings during the past couple of months. This is not a comprehensive list of all actions taken, but a good summation. If you have questions about anything mentioned in this column, please contact me or one of the Board members.

Administrative Violation Letters were sent to homeowners for the following reasons: 2 letters were sent regarding trash cans stored in front of the house. 2 letters were sent regarding rotted garage door panels. 1 letter was sent regarding a pet violation; 1 letter was sent regarding a non-standard mailbox; 1 letter was sent regarding an unauthorized paint color change; 1 letter was sent regarding a torn window screen.

STM, the Association's landscape contractor resubmitted proposals for new landscaping at all of the Association's entrances, which the Board approved.

Board member Rob Strupp submitted his resignation, effective at the conclusion of the April annual meeting.

The Board is waiting for a reply from Supervisor Michael Frey (R-Sully) regarding a formal request to VDOT for two four-way stop intersections in our community.

**Operations** Proposals for painting and renovation work to the pool house for completion in the Spring are being submitted to the Board. A proposal from Chesapeake Design, for preparation of a reserve study for the Association, was presented and approved by the Board. Management has arranged for a contractor to remove graffiti on the bench at the torched tot lot. In addition, a "No Motorized Vehicles" sign has been ordered for replacement at the entrance to this area. Management has arranged for the completion of all pool-area repair work and Spring cleaning.

**Financial** Two debtor status reports from the Association's attorney were presented to the Board. Financial statements for the end of 1997, as well as for January and February were presented to the Board, and approved.

Swim season begins just after Memorial Day, which is not that far away! Sign ups will take place at the HOA Annual Meeting, Tuesday, April 21st and Saturday, May 2nd at the pool between 1:00 p.m.-3:00 p.m.

Nearly everyone in this community plants spring flowers. We hope you will support our swim team by purchasing your flowers from us. Marie Vanderhoof has done a fabulous job in securing competitive prices and quality plants from Meadows Farms. They deliver our plants right to the pool in time for planting (May 2nd). Return your spring flower order form by April 15th (order form is on page 11). Late orders will be accepted at the HOA meeting on April 21st.

If you are new to Armfield or just need some information about our swim team, please contact Wanda Rixon at 471-9850, or attend our Swim Team Kick-Off Social on May 29th at the pool.

Briefly, the Armfield Stingrays is our neighborhood team. We are members of the Colonial Swim League and we compete against neighboring teams on Saturday mornings and Wednesday evenings. Our Swim Team Board hires head and assistant coaches each year who conduct practice every weekday from Memorial Day through July. Children ages 5 through 18 may participate. Any child who can swim one length of the pool is welcome to join the team. It's a short season, but great fun for kids and parents. So check us out!

The cost for signing up has increased slightly, but is still the best bargain in town. Coaches are simply asking for more money these days and they are getting it from other teams. To stay competitive, we have to pay more too. Aside from coaches' salaries, we also have to pay league fees, insurance for each swimmer, and for supplies such as ribbons, clip boards, watches, lane lines, etc. The fees are:

#### First child: \$60.00 Second child: \$40.00 Third+ child: \$20.00

The Armfield Farm Swim Team Board consists of seven parents. There are also several committees.

At the end of this season, four Board members' terms will expire: Deborah Broderick, Rosellen Mathey, Keith Poulson and Mary Giel. Nominations will be accepted throughout the swim season and an election will be held at our year-end party, tentatively scheduled for July 26. More information will follow.

### Consumer Product Safety Commission & Recalls

Last month the U.S. Consumer Product Safety Commission released 16 press releases regarding the recall and safety information on various commercial products on the market today. Most noteworthy for parents to heed are the changes in the Flammable Fabrics Act pertaining to childrens sleepwear, the recall of the Evenflo On My Way Infant Car Seats/ Carriers, Fisher-Price recall of popular Infant Toys, and the recall of the Norco Products USA Bike Passenger Trailers, all summarized here.

Flamable Fabrics Amendment This new amendment gives more specific guidelines on using oversized cotton daywear clothing for sleepwear. The purpose is to protect an annual estimated 300 emergency room-related burn injuries to children.

Infant Car Seats Evenflo is recalling 800,000 of its On My Way Infant Car Seats/ Carriers (model numbers 207 and 492). The latching mechanism in the carrying handle will unexpectedly release causing the carrier to flip if being hand-held or becoming free from the base unit if used as a car seat. Serious injuries have been reported. Owners should stop using this unit and contact **Evenflo** at 1 800 203-2138 to receive a free repair kit.

**Bike Passenger Trailers** Norco Products USA is recalling 450 of their bike trailers designed to carry one or two small children. Metal fatigue in the hitch components could cause the trailer to break loose from the bike and serious injuries to young passengers. For information on free repairs, call **Norco** at 1 800 521-9088.

**Fisher-Price Infant Toys** A recent popular infant toy, a kitchen refrigerator magnet in the shape of a large, partially eaten cookie is being recalled due to the magnet inadvertently falling off and causing a choking hazard. It was sold as a set of three called the Refrigerator Activity Magnet Set No. 71126. The Magic Motion Mobile No. 71153 is also being recalled because some of the pieces can fall off into the crib and injure infants. Remove these toys from your children and contact **Fisher-Price** for replacement at 1 888 407-6479.

## Community Regulations

### Pool Registration Is Coming Soon

Hard to believe that it's almost time for pool registration! The Pool Registration Packets were mailed to all owners (not tenants) on April 1st. **Please** read your entire packet very carefully. Do *not* throw it away! The registration procedures, instructions on filling out the forms, and which forms you need to fill out, are all clearly explained in your registration packet. Instructions on pool entry procedures and the 1998 pool rules also are included, so hold on to your packet throughout the season for reference. Even if you registered last year, you still must submit a 1998 pool registration form in order to enter the pool this year.

The pool opens on Saturday, May 23rd. In order to guarantee that your pool registration is processed on time for opening day, return your form by no later than May 1st. Registrations returned after the pool has opened for the season will be processed as quickly as possible. However, it may take a few days, so you might not be able to enter the pool on the same day.

The following is a summary of the pool registration procedures. Please note the different procedures which must be followed for tenants and off-site owners. Again, read your Pool Registration Packet completely before you return your registration form. Note: Assessments must be current before registrations are processed!

**Registration Procedures**

- 1. Complete and return the pool registration form to Armstrong Management Services as soon as possible and no later than May 1st. One form may be used for all members of your household (see below for "household" definition).
- 2.All pool passes will be maintained on file at the pool pool passes will not be sent in the mail.

- 3. For the purposes of the pool registration application, a household is defined as follows: A household may consist of persons living in a dwelling for more than six months of the year, or of children that are college students or are from a previous marriage and will be residing with you for the summer. All will be considered part of the household. Grandchildren or other children who do not reside in the home may not be considered part of the household, and will instead be required to enter the pool as guests. Off-Site Owner/Tenant Registration
- 1. If your home is leased and you desire pool privileges for your tenant(s), a Non-Resident Homeowner Statement must be completed by the owner and signed by both the owner and tenant. The owner will be transferring his pool privileges to his tenant, and the owner will not be able to use the pool.
- 2. A completed and signed Non-Resident Statement, Pool Registration Form, and Pool Rules should be forwarded by the owner to the tenant.
- 3. The tenant must fill out the pool registration form, and both forms must be returned in order for the tenant to be registered for the pool. If both forms are not filled out, signed, and returned, the tenant will not be registered for the pool.

#### **Child Care Registration**

The Association will allow residents who provide child care for children who do not live in Armfield to purchase pool memberships for these children in lieu of buying a guest pass every day. A \$35 membership fee must be paid for each child (12 and under) and written permission must be obtained from their parents granting permission to use the pool and stating that they will hold Armfield Community Association harmless in the event of an accident/ injury to the child. This type of membership would only be good on weekdays between the hours of pool opening to 5:00 p.m.

### **Running for Office**

Three members of the Armfield HOA have been nominated for positions on the Board. Their bios, as submitted to Armstrong Management Services, Inc., follow:

#### JOHN MULLINS

I have over 18 years of experience in organizational development, total quality and human resources management at the federal and local governmental levels. Much of my time is devoted to leading executivelevel teams toward improved organizational and leadership performance, conducting inter-governmental reengineering efforts involving business and public interest groups, and participating in government-wide benchmarking activities. In my managerial roles, I have been responsible for project management, budget, personnel administration and information technology.

#### DAN GORDON

When my family moved to this community in 1994, we were impressed by the obvious pride individual home owners took in their homes and gardens. One of the reasons we decided to live here was our anticipation that Armfield would provide a safe, clean and nurturing environment for our young children with its ample amenities and close proximity to fine public schools. We have not been disappointed. My vision for Armfield is a community of neighbors in which we know each other, spend more time together, and take an active pride in the neighborhood by participating in its running. I would welcome the opportunity to continue serving you this year to help fulfill this vision.

### Rezoning of Adjacent Property How about a McDonald's or Mobil in Your Backyard?

On March 17, 1998, the Fairfax Zoning Office accepted rezoning and special exception applications from Chantilly 657 Associates LLC to rezone a parcel of land that borders Centreville Road and adjoins the Sully Place Shopping Center, for the purpose of building two fast food restaurants, a service station/mini-mart, a drive thru bank and drug store. The application asks that the property, which is currently zoned R-1, (one home per one acre) be changed to C-6 (commercial - retail).

If permitted, these fast food restaurants, gas station, etc. would be approximately 1000 feet from the homes on Southernwood Court and less than 300 feet from our neighbors homes on Louise Avenue. The service station/mini-mart would be authorized to be open 24 hours a day and the fast food restaurants would be open until midnight, or later, every night.

Keith Martin, the attorney representing the applicant, Chantilly 657 Associates, LLC has been invited to speak at our annual meeting on April 21 at Lees Corner Elementary School for the purpose of presenting plans and to answer questions. This information was not noted in the Special Notice sent to all homeowners regarding the Annual Meeting because it was received subsequent to that printing.

The next step in this process is for the Fairfax Zoning Office to assign a Planner to this application and to schedule a public hearing. The Planning Office will provide 30 days notice prior to the public hearing by posting a sign on the property, stating where and when the meeting will be held.

If you have any opinion on this issue it is important that you attend the public hearing. In addition, the Zoning Director asks that you send your written comments by **April 21, 1998**, to her, Barbara A. Byron, Director, Zoning Evaluation Division, Office of Comprehensive Planning, 12055 Government Center Parkway, Fairfax, Virginia, and reference the following application **No. R21998-SU-013/SE98-Y-015/SE98-Y-013/ SE98-Y-014/SE98-Y-016/SE98-Y-017**. ### Franklin Middle School On the Decline?

Remember Franklin Middle School beautifully maintained, well equipped, exceptional instructional opportunities-rated one of the highest among Fairfax County Schools. This may all just be a memory if the school board has it's way. For years Franklin was overcrowded, but under Johnnie Hamilton's leadership the students thrived and excelled. Now that a new middle school has been built. Franklin will be underenrolled. Johnnie Hamilton is retiring and the many programs that were offered to our students are disappearing. In addition to cutting the staff, the school board is cutting classes. For the moment they will not offer Japanese, German, peer mediation or technology classes. In the past, many 8th graders taking these classes received high school credit for them. That will no longer be an option.

The staff at Franklin feel that the quality of instruction will be adversely impacted if these cuts are allowed to take place. They have asked the school board to reconsider the boundary changes and to rework them so that they will not undermine the school's instructional programs. 
