Administrative:

1. The minutes for the January 27, 2005 Board meeting were approved.
2. The next Board meeting is scheduled for April 28, 2005 at the St. Veronica parish center, room P203.
3. The annual meeting has been tentatively scheduled for May 19, 2005, pending confirmation of availability of the school.

Report of Committees:

1. Architectural: Revised Architectural Guidelines and Maintenance Standards are being reviewed by the ARC.
2. Pool Committee: Pool house spring clean-up party to be organized.
3. Communications: Newsletter to be published in mid-April.
4. Web Site: Armstrong notified the Board that their web site is now up and running and is available for customer use. Charlie Dutton will discuss with Barbara.

Management Agent Report:

1. Management provided an architectural chart indicating pending/complete ARC applications.
2. The action list was reviewed.
 - a. Item #1, Phone conduit at pool: Tim Murray will discuss options with DPW.
 - b. Item #9, Sandwich board refurbishment: complete
 - c. Item #11, Liriope planting: in progress, to be completed in April.
 - d. Item #12, Entrance light proposals: Proposal received from PSE, additional proposals to be obtained.
 - e. Item #14, Road sign review: complete.
 - f. Item #16, Roads condition review: Management has completed a review of all road conditions and has provided a list to VDOT.
3. Management provided an updated violation chart and list of recently approved ARC applications.
4. Management recommended that the spring walk thru be delayed until the new Architectural Guidelines and Maintenance Standards are completed and distributed.

Board of Directors Meeting Minutes Continued

Unfinished Business:

1. A proposal from Valley Crest to plant River Birch trees at the Centerville Rd entrance was again tabled, pending further investigation by Dan Gordon into other potential tree selections.
2. A proposal from Webb Signs for a replacement rules sign for the pool tennis courts in the amount of \$384.00 was approved.

New Business:

1. A proposal for financial auditing services from Ahlberg & Associates for \$1,175 was approved.
2. A proposal for pool house sprinkler maintenance in the amount of \$1,120.00 was approved.
3. The Board approved a usage fee of \$300 and a certificate of insurance will be required for any third party vendors that would like to use the Association facilities for tennis lessons.
4. The Board approved by a vote of 4 to 1 (Malherek dissenting) an increase in the associate pool membership from \$395 to \$450, effective immediately.

Member Forum:

1. A letter of concern was received from a resident concerning trees on common area that are in danger of falling on the house and deck. Management will contact Valley Crest to provide a proposal for services required.

Financial Matters:

1. Management presented financial reports for the period ending February 28, 2005. There was \$34,086.32 in the operating account, \$25,019.30 in the Money Market account, and \$77,001.50 in certificates of deposit.

Executive Session:

1. Armstrong Management presented a delinquency report and a collection status report.

Volunteer Opportunity

A spring recruitment drive has been launched by the Fairfax County Health Department, in cooperation with the Fairfax County Citizen Corps Council, to add 3,000 more volunteers to its Medical Reserve Corps (MRC) by June 30. To date, approximately 3,000 medical and nonmedical volunteers are signed up and receiving training. The recruitment drive is concentrating on recruiting seasoned, experienced managers for key leader roles in the MRC.

The all-volunteer MRC is designed to augment the capacity of the public health system to respond to large scale events related to bioterrorism or widespread epidemics.

During a public health emergency, MRC volunteers would staff dispensing sites where vaccination or medication would be provided to county residents. In a worst-case scenario, this could mean providing for more than 1.2 million people in three to five days. To accomplish this, 54 teams, comprising 232 people per team, are needed.

Volunteers are needed from both medical and non-medical professions. “Our goal is to have a trained volunteer force ready to help us respond to a public health emergency affecting Fairfax County and the cities of Fairfax and Falls Church,” said Gloria Addo-Ayensu, M.D., M.P.H., county health director.

“We’re committed to this recruitment goal of 3,000 by June 30. We truly hope our neighbors in Fairfax County take this unique opportunity to give back to their community,” said Merrily Pierce, chair of the Fairfax County Citizen Corps Council.

New Area Development?

There may be a new development coming to Centreville Road by Wall Rd, Rt. 28 and EDS Dr.

The developer has proposed a town center with a mix of uses and associated residential development. Some residential units would be above retail shops and restaurants, and office use would be integrated into the town center. Some of the residential and non-residential uses would be linked to a shared parking structure in order to minimize surface parking to some small surface lots and on-street parking. In addition, a portion of the residential uses would be on the periphery of the town center. A complex of athletic fields is proposed, as well as a central plaza in the town center.

The nominator clarified as follows:

- Retail – 150,000 sq. ft.
- Office – 350,000 sq. ft.
- Live/work – 56,000 sq. ft.
- Residential – 960 units (approximately 290 single family attached and approximately 670 multifamily units) The definition of “live/work” remains unclear and needs to be clarified by the nominator.

With all that said, here's what you need to do. On the reverse side is the Armfield Directory Form that will be used to gather information for each household. Please read it over and include as much of the information as you choose. As a minimum, each resident's name and address will be printed in the directory - whether we receive a Directory Form or not. If you choose not to include any information about your household, you must opt out of the directory by signing and dating in the appropriate block on the Directory Form.

Architectural Standards

The Armfield Farm Home Owners Association (HOA) covenants require prior approval from the Architectural Review Committee (ARC) for most all exterior changes to a residence and property (i.e., alterations, additions color changes, fences, decks, sunrooms, sheds, patios, hot tubs, etc).

Charlie Dutton, HOA liaison to the ARC, is currently chairing a committee to review and update the Association's architectural requirements. They have not had a major review/update in almost ten years. The proposed changes will be posted on the HOA web page for review and comment prior to adoption.

The ARC continues to receive applications for "after the fact" approval. Prior to closing on the sale on a residential property the owner is required to obtain the HOA sign-off. This is to assure that all dues and/or fines are paid and that no unauthorized changes have been made to the property. Armstrong Mgt Services makes the inspection and issues the release for the HOA. However, when unauthorized changes are discovered during the inspection, the home owner is required to obtain ARC approval before the sale can be finalized which may delay the closing. The ARC normally meets on the first Wednesday evening of each month to review new applications and reported violations, and conduct other business.

How to "Freecycle"

You need to join the local Freecycle group!! This group is dedicated to keeping material out of our landfills by finding new owners for unwanted things – for FREE.

The local Freecycle group is for those living in Clifton, Chantilly, Centreville and South Riding. It was started in August of 2004, and almost anything is game. I have picked up packs of vacuum bags, blocks for my young daughter and some baby clothing. I have given away vases, window blinds, binders, and even lent someone a book. People post OFFER messages, with a description of the items, and a general location (you may not feel like driving to Burke for a vase). You then write directly back to that person, and arrange a pick-up. That's it!
