

COMMUNITY UPDATE

As an owner/resident of our area, you are automatically a member of the Armfield Homeowners Association The documents of Association grant the Board Directors for AHA authority over several areas within Association. The Virginia Property Owners Act also grants authority to the Association and requires certain things of the Association individual residents. State law sellers of homes disclose the fact that they belong to the Association. In addition, a seller's contract of sale must indicate that the Association exists. You must also give buyers opportunity to request information Disclosure Packet Packet) (Resale from the Association. This packet includes pertinent information about Association and the particular property (i.e. are dues paid up, and is the property in compliance with the Association documents, which are included, as indicated by the Architectural Review Committee or ARC). In turn, the Association representative, Armstrong Management Services, will provide a copy of the Disclosure Packet to the seller for a fee of \$50. Buyers may waive the right to this information. are also expressly given the right to cancel the contract within three days of receiving the packet or of being informed that it is not available (it is available).

Additionally, an amendment to the law now permits an Association to impose charges for violation of Association rules or the Declaration, if the Association

rules so provide. Based on that authority, the Board passed General Resolution 1.D-2-1991, to enforce the rules and regulations set forth in the Declaration governing AHA and the rules and regulations duly adopted pursuant thereto. The Resolution resolves that: 1.) The Board of Directors shall have the authority to assess charges against any member for any violation of the Declaration governing AHA or rules and regulations for which a member or his family members, tenants, guests or other invitees responsible. 2.) Before any charges may be assessed, the member shall be given an opportunity to be heard and represented by counsel before the Board of Directors. 3.) Notice of the Hearing shall be hand delivered or mailed by certified mail, return receipt requested, to the member at the address of record on file with the Association, at least fifteen days prior to the Hearing. 4.) The amount of any charges that are assessed shall not exceed Fifty Dollars for a single offense or Ten Dollars per day for an offense of a continuing nature and shall treated as an assessment against the member's lot. Additionally, the Association's ability to enforce a lien for assessments has been extended from 6 to 12 months by the Virginia Property Owners Act.

As of January 1, 1990, anyone who is providing care for children unrelated to them for compensation and outside of the child's own home, must either be licensed by the State of Virginia as a Family Day Care Provider or have a permit from Fairfax County as a Home Child Care Facility. The County Permit process is relatively simple, and includes criminal history and child protective services background

checks, and inspections of the home by a representative of the Fairfax County Fire and Health Departments. Because the background checks involve multiple notarized release forms, prospective applicants can feel intimidated by the packet of papers they receive. In an effort to assist providers, the Office for children is sponsoring monthly "Application Assistance Workshops" throughout the County. The next 3 workshops are scheduled as follows: Oct. 15 - Reston Regional Library, Rm 2, 6:45 p.m.-8:30 p.m.; Nov. 14-George Mason Regional Library, meeting room, 6:45 p.m.-8:30 p.m.; and Dec. 12 - Pohick Regional Library, meeting room, 6:45 p.m.-8:30 p.m.. Call <u>218-3700 or 359-8980</u> to ensure the County Staff expects your attendance.

Effective July 1, 1991, all doorto-door sales people in Fairfax County MUST have a license! Fairfax County Department Consumers Affairs, which performs the criminal background checks and issues licenses to solicitors, advises County residents that doorto-door salespersons must abide by the following rules: 1.) They must show their County license upon demand. 2.) They may not attempt to sell at a residence where a "No Peddlers or Solicitors" sign is posted. 3.) They may visit residences only between 9 a.m. and 8 p.m. 4.) They must provide, if asked, their names and the name of the company or product they represent. 5.) They must leave the premises immediately, if asked. a salesperson does not have a license, the resident should try to get his or her name and the name of the company and call the Fairfax County Police at 691-2131 or Fairfax County Department of Consumer



Affairs at 359-9161.

The Fairfax County Office of Research and Statistics recently published the 1990 Fairfax County Profile. The profile is a source book for economic and demographic data about Fairfax County. Copies are available for purchase from the Publication Counter in the lobby of the Massey Building, 4100 Chain Bridge Road in Fairfax. The cost is \$6.50 per copy.

Lastly, a County Suggestion Hotline has been established. Citizens can leave suggestions of ways to improve current County Government operations. The hotline number is 246-4000.

Presently, the twenty "Task Force 28" members, appointed from the landowners, members of the Planning Commission, and citizens groups have been meeting weekly since March 10. The aim of Task Force 28 is to create a consensus plan to guide development in this district for the next twenty years.

On August 5, 1991, a Route 28 Tax District Task Force Progress Report was presented to the Board of Supervisors. The Board accepted the Report and moved to take two actions as recommended, that is, to adopt the Interim Guidance for Zoning applications in the Route 28 Tax District, and to direct staff from the Office of Comprehensive Planning, the Office Transportation and the County Attorney's Office to proceed with a review of the Housing issue as it pertains to the Route 28 Tax District.

The next meetings of the Task Force will be <u>September 16 and September 23</u> at the Westfields Conference Center, 7:30 p.m. The TAsk Force will meet weekly until April 1992, the date of the Hearings before the Planning Commission and the Board of Supervisors.

All meetings are open to the public. I encourage interested Armfield homeowners to attend.

Do you know where your teenager is, especially between 12 midnight and 6 a.m.?
